Highlights

- We investigate portfolio selection with transaction costs and parameter ambiguity
- We derive the optimal dynamic trading rule using the robust optimization method
- The robust portfolio gives less weight to highly volatile factors
- The robust portfolio loads less on the securities with large and costly existing positions
- The robust strategy outperforms the corresponding non-robust strategy in out-of-sample tests
