Highlights:

- Classification accuracy using subjective sleep-related parameters was superior to objective measurements to differentiate chronic PTSD patients from healthy subjects.
- Combination of subjective and objective sleep-related parameters assessment appears to improve the classification accuracy for differentiating PTSD patients from healthy individuals.
