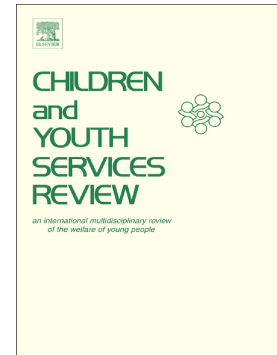

Abstract

Background: The Preventing Sex Trafficking and Strengthening Families Act of 2014 brought attention to a myriad of current issues involving youth experiences in foster care.
