Highlights:

1. IC is applied to analysis of GHB in a human urine sample for the first time.
2. The main function of ion-exclusion separation is to eliminate the urine matrices.
3. Ion-exchange chromatography is aimed to improve the sensitivity of detection.
4. The results of this method are comparable to those of GC-MS and LC-MS.
